**MOTION TO WITHDRAW AS COUNSEL FOR
SMALL FARMER’S JOURNAL, INC.**

Samuel W. Outten, S. Sterling Laney, III, and the law firm of Womble Carlyle Sandridge & Rice, LLP (“WCSR”), respectfully request that this Court permit them to withdraw as counsel for Small Farmer’s Journal, Inc. (“SFJ”) in the above-captioned matter pursuant to Local Civil Rule 83.I.07. In support of this Motion, the undersigned states as follows:

1. On September 5, 2012, the Court issued an Order to Show Cause requiring SFJ to provide the Court all written documentation or evidence as to why it should not be required to repatriate funds acquired from the illegal Ponzi scheme perpetrated by Ronnie Gene Wilson and Atlantic Bullion & Coin, Inc.
2. Messrs. Outten and Laney of WCSR entered a Notice of Appearance on behalf of SFJ on September 19, 2012.
3. On October 4, 2012, WCSR filed SFJ’s response to the Order to Show Cause.
4. For good cause, Mr. Outten, Mr. Laney and the law firm of Womble Carlyle Sandridge & Rice, LLP (“WCSR”) now needs to withdraw their notice of appearance in this Case and cease to represent SFJ in this matter.
